ACCESS SERVICE**8. Miscellaneous Services (Cont'd)****8.16 Federal Universal Service Fund Surcharge**

The Federal Universal Service Fund (FUSF) Surcharge recovers the Telephone Company's contributions to the Universal Service Support Mechanisms. Customers may certify exemption from FUSF Surcharges at the ACNA level or at the BAN level. Certification at the ACNA level will exempt all BANs under that ACNA. Certification at the BAN level will exempt only the specified BANs. FUSF Surcharge exemption certification can be completed and submitted on the Telephone Company's web site at:

(A) Application of FUSF Surcharge to Special Access Service

An FUSF Surcharge will also be assessed to customers who order Special Access Services from this tariff. The FUSF Surcharge will be determined by multiplying an FUSF Surcharge factor of 0.271 by the customer's interstate Special Access service monthly charges. (l)

(B) Application of FUSF Surcharge to Other Incidental Charges

An FUSF Surcharge will also be assessed to customers on Other Incidental Charges. Customers who participate in the Lifeline Assistance Program are not exempt from this Surcharge. The FUSF Surcharge will be determined by multiplying an FUSF Surcharge factor of 0.271 by the following Other Incidental Charges: (l)

- Nonrecurring Charge for Change in Presubscription Charge as specified in 8.5(E)(7) preceding; and/or
- Presubscribed Interexchange Carrier Charge as specified in Section 3.5(A) preceding

(C) Application of FUSF Surcharge to End User Common Line Residence Charges

Customers assessed an End User Common Line Residence charge specified in Section 4.7.1(A) preceding will be assessed a flat-rated, monthly FUSF Surcharge as specified in Section 8.16(D) following. The FUSF Surcharge will be billed to the associated end user or reseller of the local exchange services, with the exception of those customers who participate in the Lifeline Assistance program.

(D) Application of FUSF Surcharge to Enterprise Infrastructure Solutions

An FUSF Surcharge factor of 0.271 will be assessed to certain Enterprise Infrastructure Solutions services as specified in Section 10.6.1(A) following. (l)
