In addition to the above referenced changes further revisions are made to FCC Tariff No. 1, FCC Tariff No. 2, FCC Tariff No. 3, FCC Tariff No. 4, FCC Tariff No. 7, FCC Tariff No. 8 and FCC Tariff No. 9 as follows:

FCC Tariff No. 1: - Adjustments have been made to the Access Recovery Charge and DS1 Non-Competitive Channel Termination rate in the Lufkin/Conroe Market Area and Katy Market Area. Section 20 has been deleted as it is a duplicate of Section 19.

FCC Tariff No. 2: - Adjustments have been made to the Multi-Line Business Access Recovery Charge.

FCC Tariff No. 3: - Adjustments have been made to the Multi-Line Business Access Recovery Charge.

FCC Tariff No. 4: - Adjustments have been made to the Multi-Line Business Access Recovery Charge.

FCC Tariff No. 7: - Adjustments have been made to the Multi-Line Business Subscriber Line Charge, PRI ISDN Subscriber End User Common Line Charge, the Multiline Business, PRI ISDN, PBX Trunk and Business Centrex ARC and the 1.544 Mbps End User Channel Termination Charge.

FCC Tariff No. 8: - Adjustments have been made to the Multiline Business, ISDN PRI and Centrex EUCL and ARC rates.

FCC Tariff No. 9: - Adjustments have been made to the Rate Band 4 monthly Non-End User and End User Channel Termination and Channel Mileage rates for voice grade service, DS1 and DS3 and to the multiplexing rates for DS3 to DS1.

Some of this information is filed with a request that it be treated as confidential under the Freedom of Information Act. A letter requesting that it be placed under the Protective Order designated in the Tariff Streamlining Order is attached.


