SECTION 9 – END USER ACCESS SERVICES (CONT'D.)

9.5 Facilities Access Charge (FAC) *

The Facilities Access Charge (FAC) is imposed upon T-1 facilities used in connection with the Company's Point-to-Point and data services. The FAC recovers the cost of the Customer's consumption of ports on the Company's network. A FAC applies to each data and Point-to-Point T-1 circuit subscribed to by the Customer. Rates are described below:

9.6 Administrative Services Fee ("ASF")

The Administrative Services Fee is a graduated percentage monthly fee assessed on all monthly recurring charges (MRCs) to recover costs associated with tariff and price guide filings, collections, record maintenance, various state business licenses, various regulatory fees where applicable, general account servicing, and the administrative costs the Company incurs for local, state and federal governmental data gathering, record maintenance, and required reporting. This is not a tax or charge imposed by a governmental entity.
