4.1.2 Rate Regulations (Cont'd)

(H) Access Recovery Charge (ARC)

The ARC is a monthly charge billed to residential, single line business, and multiline business Customers. This charge may be combined with and reflected within the EUCL charge on the Customer's bill.

(1) Residential ARC

Both Primary and Non-Primary Residential and ISDN BRI subscriber lines will be charged the Residential ARC as set forth in 4.1.4(B)(1). (T)

Lifeline Customers are exempt from the Residential ARC. A credit will be applied to the bills of Lifeline Customers equal to the Residential ARC.

(2) Single Line Business ARC

Single Line Business Customers will be charged the Single Line Business ARC as set forth in 4.1.4(B)(2).

(3) Multi-Line Business ARC

Multiline Business and Centrex lines will be charged the Multiline Business ARC as set forth in 4.1.4(B)(3). Each ISDN PRI service will be assessed the equivalent of five Multi-Line Business ARC charges. (T)
