Revisions are proposed on behalf of JSI carriers who are not members of the National Exchange Carrier Association Common Line Pool and therefore bill common line charges and related Federal Universal Service Charge ("FUSC") charges pursuant to JSI Tariff FCC No. 1. Proposed revisions reflect the increase from the currently effective 27.1% to 31.8% for the first quarter of 2021.¹

Revisions are also proposed on behalf of the below carriers whose Common Line rates and charges are tariffed at Section 17, Common Line Rates and Charges – Alternative Connect America Model Carriers:


