This access service tariff filing proposes to revise interstate access service rates to become effective July 1, 2021, pursuant to FCC Order DA 21-568 issued on May 14, 2021, regarding July 1, 2021 Annual Access Charge Tariff Filings, WC Docket No. 21-148.

Pursuant to Commission's Rules, an electronic letter of transmittal with signature, Form 159, and payment for \$960.00 has been made through the FCC Fee Filer System as of this date.

The filing made on June 16, 2021, to be effective July 1, 2021, revises the Access Recovery Charge (ARC) pursuant to 47 CFR §51.917(e), and implements changes adopted in the Commission's 8YY Access Charge Reform Order (FCC 20-143, rel. Oct. 9, 2020) for the issuing carriers in the Alexicon Telecommunications Consulting, Inc. Tariff F.C.C. No. 1. This filing also revises, where applicable, the issuing carriers' special access service rates to reflect

revisions in the interstate authorized rate-of-return. In addition, this filing revises, where appropriate, special access rates in compliance with the Commission's Consumer Broadband-Only Line rate and revenue requirement rules. Finally, Commission actions regarding Access Recovery Charge (ARC) imputation on Consumer Broadband-Only Lines are reflected in this tariff filing.
