("HTI") submits its Tariff Review Plan ("TRP") and necessary support data as required by the Commission as authorized in the Commission's 2021 TRP Notice released May 14, 2021 (DA 21-568) and in compliance with Sections 61.41 through 61.50 of the Commission's rules.

HTI and Cincinnati Bell ("CBI") merged effective July 2, 2018. Therefore, the data submitted in support of the Access Recovery Charge ("ARC") transitional recovery mechanism as required by the Commission and in compliance with Sections 51.700 through 51.715 and 51.901 through 51.919 of the Commission's rules contains data for both HTI and CBI study areas. Supporting materials for the FCC Tariff No. 1 revisions as described under Section 61.38 of Commission's Rules are included with this filing. Section 1 of the Description and Justification addresses HTI's annual access tariff filing, and Section 2 addresses the combined HTI and CBI filings pursuant to the *USF ICC Transformation Order*.
