The Tandem Switched Termination rate recovers a portion of the costs of the circuit equipment that is necessary for the termination of each end of the Tandem Switched Facility.

The Tandem Switched Termination rate set forth in Section 16 following is applied on a per access minute basis (for all originating and terminating minutes of use routed over the facility) at each end of each measured segment of Tandem Switched Facility (e.g., remote office to host office, host office to tandem office, or host office to Feature Group A dial tone office). When the Tandem Switched facility mileage is zero, neither the Tandem Switched Facility rate nor the Tandem Switched Termination rate will apply.

Direct Trunks ordered into a class 4/5 office having the capability of carrying traffic to or from other offices, shall be considered a direct trunk to the tandem, and the tandem switching element will apply to all minutes carried over the trunk.

Pursuant to FCC 20-143, released October 9, 2020, tandem switching and transport for originating 8XX traffic will be charged via a single usage sensitive Joint Tandem Switched Transport Access Service rate applied per access minute.
