The accompanying tariff materials issued by The Chillicothe Telephone Company (Chillicothe) (FRN #0005-0973-81), and bearing F.C.C. No. 1, effective July 1, 2021, are sent to you in compliance with the requirements of the Communications Act of 1934, as amended and pursuant to the Commission's Rules.

The purpose of the filed tariff materials is to make several changes in Chillicothe's interstate switched and special access rates. A Description and Justification, tariff review plan (TRP), and appropriate supporting materials accompany this filing.

In addition, Chillicothe has made the tariff revisions necessary at this time to implement the Commission's requirements regarding the transition of interstate and intrastate toll-free (or 8YY) originating end office access service rates to bill-and-keep over a three-year period.



These CAF ICC materials are also being filed with the Universal Service Administrative Company (USAC) and the relevant state commission.
