B) End Office

The End Office rate category provides the End Office switching functions necessary to complete the transmission of Interexchange Communications to and from End Users. End Office charges may include local switching ("LS"), trunk port ("Port"), and other specified rate elements, which are applied on a per minute of use basis.

C) 8XX Data Base Access Service
