The mileage to be used to determine the monthly rate for the Local Transport is based on airline distance, using the V&H coordinates method. (This method is set forth in National Exchange Carrier Association Tariff F.C.C. No. 4.) Mileage between a remote office and an end office will be measured as separate segments and will be rated on a per minute of use per mile basis.

When Direct Trunked Transport is ordered between the serving wire center and the end office, mileage is normally measured in one segment from the serving wire center to the end office. When Direct Trunked Transport is ordered between a serving wire center and a tandem and Tandem Switched Transport is ordered between the tandem and the end office, mileage is calculated separately for each segment.

6.6.8 Toll Free Number Data Base Access Service

Toll Free Data Base Access Service is provided with FGC or FGD Switched Access Service. When a 1+800 series + NXX-XXXX call is originated by an end user, the Telephone Company will utilize the Signaling System 7 (SS7) network to query an 800 data base to perform the identification function. The call will then be routed to the identified customer over FGC or FGD switched access. The 800 series includes the following service area codes: 800, 888, 877, 866, 855, 844, 833 and 822. (T)

The manner in which Toll data base access service is provided is dependent on the availability of SS7 service at the end office from which the service is provided. (T)

Query charges as set forth in Section 10 following are in addition to those charges applicable for the Feature Group C or Feature Group D switched access service.
