1. DEFINITION OF TERMSN-1 Carrier:

The carrier that is delivering a call to the Company's switch and is responsible for determining the status and Location Routing Number of the dialed NXX.

Network Services:

The Company's telecommunications Access Services offered on the Company's Network.

Non-Recurring Charges:

The one-time initial charges for services or facilities, including but not limited to charges for construction, installation, or special fees, for which the Customer becomes liable at the time the Service Order is executed.

Non-Toll Free

All calls that are not toll free (8YY) as established by the FCC's 8YY Access Charge Reform Order (FCC 20-143) released on October 9, 2020.

On-Hook:

Out of Band Signaling:

An exchange access signaling feature which allows customers to exchange call control and signaling information over a communications path which is separate from the message path.

Location where the Customer maintains a facility for purposes of interconnecting to the Company's Network

1. DEFINITION OF TERMSSignaling System 7 (SS7):

The common Channel Out of Band Signaling protocol developed by the Consultative Committee for International Telephone and Telegraph (CCITT) and the American National Standards Institute (ANSI).

Switched Access Service:

Access to the switched network of an Exchange Carrier for the purpose of originating or terminating communications. Switched Access is available to carriers, as defined in this tariff.

Toll Free Code (TFC)

The term "Toll Free Code" denotes a three-digit Numbering Plan Area (NPA) or Area Code that is specifically assigned by the telecommunications industry for use by Telecommunications Service Providers in the provision of telephone numbers that, unlike traditional telephone numbers and calls, when dialed are toll free to the originating caller. The specific codes assigned and used, or reserved for use, for this purpose are 800, 822, 833, 844, 855, 866, 877, and 888.

Toll Voice over Internet Protocol - Public Switched telephone Network ("VoIP-PSTN"):

The term Toll VoIP-PSTN Traffic denotes a Customer's interexchange voice traffic exchanged with the Telephone Company in Time Division Multiplexing format over PSTN facilities, which originates and/or terminates in Internet Protocol (IP) format. Toll VoIP-PSTN Traffic originates and /or terminates in IP format when it originates from and/or terminates to an end user customer of a service that requires IP-compatible customer premises equipment.

Trunk:

A communications path connecting two switching systems in a network, used in the establishment of an end-to-end connection.

Wireless Provider:

Any carrier authorized to operate as a provider of cellular, personal communications, paging or any other form of wireless transmission.

4.2 Rate Categories (Cont'd)4.2.2 Tandem Switching

Tandem Switching provides for the use of tandem switching equipment and includes costs of switching and other costs associated with (originating and terminating) transfer and termination of the call. Included in Tandem Switching are:

Tandem Switching which is assessed on a per access minute basis for all switched access minutes that are transported from one Customer to another Customer over Tandem-Switched Transport Services through a Company switch.

Tandem Switched Transport Facility which is assessed on a per minute per mile basis for all switched access minutes that are transported from one Customer to another Customer over Tandem-Switched Transport Services through a Company switch. Distance will be measured from the Company switch to the next interconnecting switch.

Tandem switched transport termination which is assessed on a per minute basis and includes the non-distance sensitive portion of Switched Transport.

Effective July 1, 2021, as established in the 8YY Access Charge Reform (FCC 20-143), existing tandem switching charges and transport charges for originating 8YY traffic are eliminated and a single joint tandem switched access service rate element for 8YY originating access service is established. This originating rate will be set forth as 8YY Joint Tandem Switched Transport, following.
