SECTION 1- DEFINITIONS (Cont'd.)

Gbps - Gigabits per second; billions of bits per second.

GTA - Global Title Address; software instructions in the Signal Transfer Point (STP) that identify the signaling message destination.

ICB - Individual Case Basis; standard tariff pricing is not available. Each installation is individually priced and negotiated with the customer.

JTST – Joint Tandem Switched Transport; rate element assessable for the transmission of originating Toll Free 8XX minutes. The rate element includes both the transport between the end office and the tandem switch and the tandem switching. It does not include transport of traffic over dedicated transport facilities between the serving wire center and the tandem switching office.

Kbps - Kilobits per second; 1000s of bits per second.

LATA - Local Access and Transport Area. A geographic area established by the US District Court for the District of Columbia in Civil Action No. 17-49, within which a Local Exchange Company provides communications services.

LEC - Local Exchange Company

Mbps - Megabits per second; millions of bits per second.

OPC - Originating Point Code; a field within a signaling message that identifies the originating network Signaling Node.

POP - The physical location of an interexchange carrier's facilities.

SSP - Service Switching Point; an end office or tandem switch equipped with signaling link hardware and software to perform Signal Point functions. SSPs participate in processing a CCS/SS7 call by requesting and responding to call processing instructions issued by the SCP.

STP - Signal Transfer Point; a specialized packet switch that routes and translates signaling messages in the CCS network.

5.2 Rate Categories (Cont'd.)

Tandem Switching

The Tandem Switching rate category establishes the charges associated with “switching” a call through the Company’s tandem switching office from the “incoming” trunk group to the “outgoing” trunk group. (C)

Tandem Switching charges apply when the Company passes a call between the Customer and another carrier, including a CMRS provider or Interconnected Wholesale provider. Tandem switching charges may include charges for multiplexing and associated trunk ports, where applicable. Tandem Switching may include any functional equivalent of the ILEC Tandem Switching service provided by the Company via analogous facilities.

Joint Tandem Switching Transport (JTST) charges apply when the Company passes an Originating Toll Free 8XX call between another carrier or VoIP Provider and the Customer. (N)

5.2.2 Toll-Free 8XX Data Base Query

The Toll-Free 8XX Data Base Query Charge, will apply for each Toll-Free 8XX call query received at the Company’s (or its provider’s) Toll-Free 8XX database.
