The filing, to become effective January 1, 2022, consists of tariff pages as indicated on the following check sheet:

Revisions are proposed on behalf of JSI carriers who are not members of the National Exchange Carrier Association Common Line Pool and therefore bill common line charges and related Federal Universal Service Charge ("FUSC") charges pursuant to JSI Tariff FCC No. 1. Proposed revisions reflect a decrease from the currently effective 29.1% to 25.2% for the first quarter of 2022.¹

This filing also proposes revisions on behalf of certain carriers who elected incentive regulation for Business Data Services to reflect detariffing of higher capacity and packet data rates effective January 1, 2022. These carriers include, Home Telephone ILEC, LLC d/b/a Home Telecom (SC), Lumos Telephone of Botetourt Inc. (VA), BEK Communications Cooperative (ND), Inter-Community Telephone Company, LLC (ND) and the Premier Companies (Mutual Telephone Company (IA), Northern Iowa Telephone
