This filing proposes tariff revisions to reflect the change in the Federal Universal Service Fund Contribution Factor for the 2<sup>nd</sup> Quarter of 2022, pursuant to the Commission's Public Notice, "Proposed Second Quarter 2022 Universal Service Contribution Factor, CC Docket No. 96-45," DA 22-268 (rel. March 14, 2022). Specifically, ZiPLY Fiber proposes to increase its charge to recover its Federal Universal Service Fund contributions to reflect the change in the FCC's factor from 25.2% to 23.8%, effective April 1, 2022.
