The accompanying tariff material, issued on behalf of U S WEST Communications, Inc., d/b/a U S WEST Communications (USWC), and bearing Tariff F.C.C. No. 5, effective as reflected on the attached tariff pages, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended.

This filing is being made by USWC under authority of Special Permission No. 00-007 and is being made in two parts.

Part I

In the first part of this filing, USWC is rearranging Section 7, Private Line Transport Service of its Tariff F.C.C. No. 5 in its entirety to make the tariff easier to read and understand. This filing, which is a complete rearrangement of Section 7, is the first part of a multi-filing plan to rearrange USWC's Tariff F.C.C. No. 5. In addition to the rearrangement of Section 7, USWC is also making the necessary changes to other Sections, that currently reference Section 7, to reflect the paragraph number changes in Section 7. USWC is also adding a new alphabetical Index to Section 7 (and eventually all Sections in Tariff F.C.C. No. 5) and changing the tariff Table of Contents to reflect the new Section 7 structure. The rearrangements being made in this filing do not change rates, language, regulations or terms and conditions of the tariff material.

As a result of the above tariff material rearrangements, USWC's Section 7 is left with several clusters of blank "dot" pages. Placement of tariff language on these "dot" pages, once the rearrangement is made, no longer enhances in fact actually deters from the information flow of the tariff. These clusters of pages are being removed from the tariff in Part II of this filing.

In the second part of this filing, USWC is removing specific "dot" pages, where those pages fall in a consecutive sequence of four or more. By removing these pages (left blank by Part I of this filing) from the tariff, the flow of the tariff and consequently its ease
