The accompanying 2022 Annual Access Charge Tariff Filing of Iowa Network Services, Inc. ("INS") is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended.

This 2022 Annual Access Tariff Filing is filed in accordance with the procedures set forth in *July 1, 2022 Annual Access Charge Tariff Filings*, Order, WC Docket No. 22-108, DA-22-407 (rel. April 15, 2022) (the "*Procedures Order*") and includes cost support required by the Commission's Order, *In the Matter of July 1, 2022 Annual Access Charge Tariff Filings*, Order, DA 22-494, WC Docket No. 22-108 (rel. May 9, 2022). INS also submits materials consistent with the Commission's *Second Rate Order* issued on February 28, 2019.¹ Pursuant to the attached study for the test period ending June 30, 2023, INS proposes to maintain its existing switched transport rate of \$0.00411 per access minute. Because this submission contains materials required by the

As required by the *Procedures Order*, INS is submitting its 2022 Annual Tariff Review Plan and associated documents electronically using the Commission's Electronic Tariff Filing System ("ETFS"), with confidential materials being submitted in accordance with the procedures in the *Protective Order* issued in the *Second Rate Order* proceeding. Since INS is not proposing any new or revised rates or regulations at this time, no tariff pages are included with this filing. A filing fee is not required to be submitted with this submission, as set forth in Section 61.15(i) of the Commission's rules, 47 C.F.R. § 61.15(i).
