In compliance with the FCC Order, Verizon Access: 1) reduces certain of its Direct Connect originating non-8YY usage charges; 2) reduces its Direct Connect originating 8YY usage charges; 3) reduces certain of its Tandem Connect without Tandem Switching originating non-8YY usage charges; 4) reduces its Tandem Connect without Tandem Switching originating 8YY usage charges; 5) reduces certain of its Tandem Connect with Tandem Switching originating non-8YY usage charges; 6) reduces its Tandem Connect with Tandem Switching originating 8YY usage charges; and 7) adds to the tariff Zone 2 originating non-8YY usages charges for Direct Connect, Tandem Connect without Tandem Switching and Tandem Connect with Tandem Switching for ID and PA. This filing is made pursuant to Section 61.26 of the Commission's rules.
