The accompanying tariff material issued by Lafourche Telephone Company, LLC (“Lafourche”) (FRN #0001-7147-81), and bearing Tariff F.C.C. No. 2, effective July 1, 2022, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended.

This filing proposes to revise interstate switched access rates and permissively detariff broadband transmission services and to continue to offer on a detariffed, common carriage basis effective July 1, 2022 in accordance with the Federal Communications Commission (“FCC”) Wireline Competition Bureau – Pricing Policy Division’s (“WCB-PPD”) *July 1, 2022 Annual Access Charge Tariff Filings Order*<sup>1</sup> and the *8YY Access Charge Reform Order*<sup>2</sup>. Supporting material required by the WCB-PPD is also included in this filing.<sup>3</sup> Lafourche is a Subset 3 carrier with 50,000 or fewer access lines and, therefore, is submitting this filing pursuant to Section 61.39 of the Commission’s rules.
