EXPLANATION OF SYMBOLS

The following symbols shall be used in this Tariff for the purposes indicated below.

- C - To signify a changed regulation
- D - To signify a discontinued rate or regulation
- I - To signify a rate increase
- M - To signify a matter moved or relocated without change
- N - To signify a new rate or regulation
- R - To signify a rate reduction
- S - To signify a reissued matter
- T - To signify a change in text but no change in rate, regulation or charge

**SECTION 4 - PAYMENT ARRANGEMENTS (CONT.)****4.9     Disputed Bills**

- 4.9.1     The Customer may dispute a bill in good faith only by written notice to the Company. Any Customer who has a dispute shall be advised by the Company that the Customer may file a formal or informal complaint with the Commission. Such claim must identify in detail the basis for the dispute, and if the Customer withholds disputed amounts, it must identify the account number under which the bill has been rendered, the date of the bill, and the specific items on the bill being disputed to permit the Company to investigate the merits of the dispute. (C)
- 4.9.2     The date of the dispute shall be the date on which the Customer furnishes the Company with their written dispute via email to [support@nos.com](mailto:support@nos.com) or through the Company's web portal. The dispute must include the following account information:
- A clear explanation of the basis of the dispute, including what the Customer believes is incorrect (e.g., nonrecurring charge; mileage; circuit identification) and the reason why the Customer believes the bill is incorrect (e.g., monthly rate billed not same as in tariff; facility not ordered; service not received);
  - The account number under which the bill was rendered;
  - The date of the bill;
  - The invoice number;
  - The exact dollar amount in dispute;
  - The universal service order code(s)(USOCs) and/or rate element associated with the service;
  - Details sufficient to identify the specific amount(s) and item(s) in dispute;
  - The name of the person initiating the Customer's dispute;
  - Additional data as the Company reasonably requests from the Customer to resolve the dispute. The request for such additional information shall not affect the Customer's dispute date as set forth preceding.
- 4.9.3     The date of resolution is the date the Company completes the investigation and credits the Customer account or confirms the billing as accurate and denies the dispute.
- 4.9.4     In the event that a billing dispute concerning any charges billed to the Customer by the Company is resolved in favor of the Company, any payments withheld pending settlement of the dispute shall be subject to the late payment penalty set forth in 4.2.6 preceding.

**SECTION 7 - NOTICES AND COMMUNICATIONS**

- 7.1 The Customer shall designate on the Service Order an address to which the Company shall email, mail or deliver all notices and other communications, except that Customer may also designate a separate email address to which the Company's bills for service shall be sent.

- 7.3 All notices or other communications required to be given pursuant to this Tariff of the Company will be in writing. Notices and other communications of either party, and all bills sent by the Company, shall be deemed given: (i) when delivered in person, (ii) 24 hours after deposit with an overnight delivery service for next day delivery, (iii) the same day when sent by facsimile or email transmission (confirmed by sender's equipment) during normal business hours, receipt confirmed by sender's equipment, or (iv) three Business Days after deposit in the United States mail, postage prepaid, registered or certified mail, return receipt requested.
- 7.4 The Company or the Customer shall advise the other party of any changes to the addresses designated for notices, other communications or billing, by following the procedures for giving notice set forth herein.

**SECTION 13 – SWITCHED ACCESS SERVICE (CONT.)****13.2 Provision and Description of Switched Access Service Agreements (Con't)****13.2.4 Entrance Facility**

Direct Connect and Tandem Switch Connection arrangements require the establishment of a connection between the Customer's premises and the relevant Company switch(es). Such connection is established using an Entrance Facility arrangement as described in this section.

An Entrance Facility element, combined with direct trunked transport provided by the Customer or through separate arrangements not pursuant to this Tariff, provides the communication path between a Customer's Premises in a local access and transport area and a Telephone Company switch in the same local access and transport area for the sole use of the customer. As described in Section 14 of this Tariff, the Entrance Facility element consists of a fixed monthly charge. This arrangement is required whether the Customer's Premises and relevant Telephone Company switch are located in the same or different buildings. Where facilities are available at the time of a Customer order, the Company will provide the Entrance Facility at the rates specified in Sections 14.12.10, following. Where facilities are not available at the time of a Customer order, the Company may provide the Entrance Facility on a Special Construction basis as specified in Section 11, preceding.

**(C)**

If a Customer has no Premises or facilities in the local access and transport area where a Company switch is located to which the Customer seeks to connect, the Company will arrange for transport from a mutually agreeable location in the local access and transport area where the Customer has Premises or facilities to the local access and transport area where the relevant Company switch is located. Due to the variability of possible arrangements affected by this provision, the rate(s) applicable to any such arrangement will be developed on an individual basis in accordance with the provisions of Section 11 of this Tariff.

**13.2.4.1 Multiplexing.**

The Company's switches use DS3 and/or VoIP ports. A Customer may choose to deliver traffic to or receive traffic from the Company at the 1 level, in which case multiplexing charges will apply as set forth in Section 14 following.

**13.2.4.2 Switch Port.**

An Entrance Facility/Direct Trunked Transport arrangement will terminate in one or more DS3 (or functional equivalent) ports on the relevant Company switch. Charges for these ports will apply as set forth in Section 14 following.



**SECTION 13 – SWITCHED ACCESS SERVICE (CONT.)****(N)****13.2 Provision and Description of Switched Access Service Agreements (Con't)****13.2.4 Entrance Facility (Con't)****13.2.4.2 Switch Port. (Cont.)**

A Dedicated Tandem Trunk Port is provided for all facilities terminated on the serving wire center side of the access tandem when the customer has requested tandem routing. The Dedicated Tandem Trunk Port rate provides for the termination of trunks in tandem ports on the Customer side of the Access Tandem. Dedicated Tandem Trunk Port rates are billed for both originating and terminating usage on a monthly recurring basis.

- a. For those Customers who choose to connect with the Company's Tandem on a direct basis (i.e., by choosing to purchase Tandem ports dedicated to the sole use of that Customer), the "per DS1" port charges in Section 14.12.12 below apply. When dedicated facilities connecting to a tandem trunk port are supported by time division multiplexing (TDM) technology, the "per DS1" port charges shown in Section 14.12.12 below are applied for each individual DS1 (e.g., four DS1s in New York – Frontier areas:  $\$180 \times 4 = \$720$ ). When dedicated facilities connecting to a tandem trunk port are supported by session internet protocol (SIP) technology, it is assumed that each DS1 equivalent equates to 216,000 MOUs and the "per DS1" port charges in Section 14.12.12 below are applied for each individual DS1 equivalent (e.g.,  $1,000,000 \text{ MOUs} / 216,000 = \text{five DS1 equivalents}$ ; in New York – Frontier areas:  $\$180 \times 5 = \$900$ ). Fractional DS1s or DS1 equivalents are rounded up to the next whole DS1 or DS1 equivalent.
- b. For those Customers who choose to connect with the Company's Tandem on an indirect basis (i.e., by choosing not to purchase Tandem ports dedicated to the sole use of that Customer), the indirect "per MOU" port charges in Section 8.1.5(D) below apply. The indirect "per MOU" port charges assume that the portion of the port(s) provided by the Company in connection with the Customer's traffic is rated on a per-minute-equivalent basis with a monthly usage assumption of 216,000 MOU per DS1-equivalent port.
- c. When Direct Transport is provided as a DS3, DS3 to DS1 multiplexing is required.
