This filing proposes several corrections to the second step in implementing the 8YY Access Service reductions mandated in the Federal Communications Commission's October 9, 2020 Report and Order in WC Docket No. 18-156, (FCC 20-143), (8YY Access Charge Reform). Previously Transmittal No. 5 was filed on July 15, 2022, however several non-8YY Originating rates were not reduced per the benchmarking rules..
