The accompanying tariff material issued by John Staurulakis, Inc. ("JSI"), and bearing Tariff F.C.C. No. 1, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended.

The F.C.C. Registration Number ("FRN") for JSI is 0003-7481-42. The FRNs for the issuing carriers for JSI Tariff F.C.C. No. 1 ("JSI Tariff") are provided at Appendix A to this transmittal letter.

The filing, to become effective July 1, 2023, consists of tariff pages as indicated on the following check sheet:

In this transmittal, JSI proposes revisions to JSI Tariff F.C.C. No. 1 to allow transition of two (2) new issuing carriers (collectively, "New Issuing Carriers") for JSI Tariff F.C.C. No. 1 concurrent with cancellation as issuing carriers for the appropriate common line and/or traffic sensitive pools in National Exchange Carrier Association, Inc. ("NECA") Tariff F.C.C. No. 5. New Issuing Carriers are summarized at the accompanying Description and Justification Exhibit 1.

Proposed revisions provide for addition of the New Issuing Carriers to Title Pages, Table of Contents, and existing Sections 7, 8 and 16 tables to indicate which carriers offer Special Access and Public Packet Data Network services.

In addition, revisions are proposed for cancellation of two (2) carriers who are exiting the JSI Tariff F.C.C. No. 1 effective July 1, 2023. Revisions reflect removal of these carriers from the Title Pages, Table of Contents, and Carrier Tables within the regulations.

No new rate pages are included or deleted in this filing, and customers are not directly impacted.
