Dear Ms. Dortch:

On June 16, 2023, Consolidated Communications Companies (“Consolidated” or “Company”) filed revisions to FCC Tariff Nos. 1, 2, 3, 4, 6, 7, 8, and 9 under Transmittal Letter 121 with supporting documentation. The tariff revisions included in that transmittal increased the Federal Universal Service Fund (FUSF) Surcharge, reduced originating 8YY end office and 8YY query rates and revised certain other switched and special access rates. The revisions were filed in accordance with the Commission’s TRP Notices released May 11, 2023 (DA 23-386); Public Notice DA 23-507 in CC Docket 96-45 released June 14, 2023; and Report and Order, FCC 20-143 on 8YY Access Charge Reform issued by the Commission in WC Docket No. 18-156 (“Order”). Transmittal 121 was submitted on fifteen (15) days’ notice with an effective date of July 1, 2023.

Based on subsequent review, the Company determined that it inadvertently omitted rate increases for DS3 end user channel terminations in FCC Tariff No. 1 and for DS1 channel mileage termination and DS3 end user channel terminations in FCC Tariff No. 6.

Application is hereby made by Consolidated Communications Companies for Special Permission to waive the requirements of CFR Title 47, Sections 61.58 to make revisions to FCC Tariff No. 1 and FCC Tariff No. 6 on not less than one-days’ (1) notice, to allow these rate changes to become effective on July 1, 2023. Documentation supporting these rate increases was included with the documentation provided in support of Transmittal 121. Illustrative tariff pages to be included with Transmittal 122 are attached.
