By this transmittal and the accompanying attachments, Vexus Fiber, LLC (formerly known as NTS Communications, LLC d/b/a Vexus) (the "Company") submits as **Attachment 1** its Tariff F.C.C. No. 6 for the provision of switched access services, which replaces and cancels in entirety Tariff F.C.C. No. 5 of NTS Communications, LLC d/b/a Vexus. Tariff F.C.C. No. 6 reflects the name change of the Company from NTS Communications, LLC d/b/a Vexus to Vexus Fiber, LLC. Other than the Company name change, the update of the Telcordia name and formatting updates, the replacement tariff is identical to Tariff F.C.C.
