On June 27, 2023, Vexus Fiber filed Transmittal No. 1 in order to submit a replacement tariff for the provision of switched access services in connection with the Company's conversions and resulting name change from NTS Communications, LLC d/b/a Vexus to Vexus Fiber, LLC. Under that transmittal the Company inadvertently labeled the replacement tariff as F.C.C. No. 6 of Vexus Fiber, LLC, in lieu of F.C.C. No. 1, to replace Tariff F.C.C. No. 5 of NTS Communications, LLC d/b/a Vexus. Pursuant to communications with Commission staff, this Transmittal No. 2 of Vexus Fiber, LLC is being filed to withdraw the Vexus Fiber Tariff F.C.C. No. 6 and submits Vexus Fiber's initial tariff for the provision of switched access services as Tariff F.C.C. No. 1 as a replacement tariff for NTS Communications, LLC d/b/a Vexus Tariff F.C.C. No. 5; and NTS Communications Transmittal No. 7 requests cancellation of its Tariff F.C.C. No. 5, pursuant to Section 61.87(a)(1) of the Commission's rules. The Vexus Fiber Tariff F.C.C. No. 1 reflects the name change of the Company from NTS Communications, LLC d/b/a Vexus to Vexus Fiber, LLC and other than the Company name change, the update of the Telcordia name and minor formatting updates, the replacement Tariff F.C.C. No. 1 is identical to Tariff F.C.C. No. 5.
