The accompanying tariff material issued by Moss Adams LLP (“Moss Adams”), and bearing Tariff F.C.C. No. 1, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended.

The F.C.C. Registration Number (“FRN”) for Moss Adams is 0004-9542-44. The FRNs for the issuing carriers for Moss Adams LLP Tariff F.C.C. No. 1 are provided at Appendix A to this transmittal letter.

With this filing, Moss Adams is amending Transmittal No. 39 to submit updated Tariff Review Plan (TRP) Connect America Fund Intercarrier Compensation (CAF ICC) spreadsheet files as described below. Transmittal No. 39 was originally filed on June 16, 2023, and became effective July 1, 2023. As part of the support for Transmittal No. 39, Moss Adams submitted the required CAF ICC TRP spreadsheets for the 2023-2024 tariff test period.

This amendment updates the following companies’ reported tariff year 2021-2022 CAF ICC True up and tariff year 2023-2024 forecasted imputed access recovery charge on Consumer Broadband-Only Loop lines:

Additionally, this filing also provides updated CAF ICC certifications, including Not Seeking Duplicative Recovery, Carrier Eligibility for CAF ICC Recovery, Authorize Agent to File Data Reported on Behalf of Reporting Carrier, and Accuracy of CAF ICC Data.

As was the case with the confidential CAF ICC TRP files originally transmitted on June 16, 2023 under Transmittal No. 39, Moss Adams seeks confidential treatment of this data pursuant to *2023 Protective Order* designated for use in the 2023 Annual Access Charge Tariff filings proceeding.
