By this transmittal and the accompanying attachments, Zayo Group, LLC ("Zayo" or the "Company") submits its Tariff F.C.C. No. 2 for the provision of switched access services, which supersedes and cancels in entirety Tariff F.C.C. No. 2 of Electric Lightwave, LLC dba Allstream. Zayo's Tariff No. 2 is issued by the Company's Corporate Counsel and consists of an Original Title Page and Original Pages 1 through 65.

Pursuant to Section 61.87(a)(1) of the Commission's rules, the Company is also canceling the Electric Lightwave, LLC dba Allstream ("Allstream") Tariff F.C.C. No. 2. Allstream will separately submit its current Tariff F.C.C. No. 2 as a complete base tariff filing to confirm and effectuate the cancellation.

Zayo's Tariff F.C.C. No. 2 and the cancellation of Allstream's Tariff F.C.C. No. 2 are being filed with an effective date of January 1, 2024, which provides at least fifteen (15) days' notice.
