Dear Madam Secretary:

The accompanying tariff material, issued by Windstream Telephone System (“WTS”), bearing Tariff FCC No. 6 and Tariff FCC No. 7, effective April 1, 2024, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended.

This filing reduces the universal service fund factor to 32.8% pursuant to Public Notice DA 24-257, CC Docket No. 96-45, released March 14, 2024, for issuing carriers contained in the WTS Tariff FCC Nos. 6 and 7.

Additionally, this filing removes selected language regarding unbundled network elements in WTS FCC Tariff No. 6.

This filing also addresses an administrative oversight connected to a previous filing made on November 3, 2023, and removes additional language related to WTS’ Mixed Use Special Access Service in FCC Tariff No. 6. This edit is administrative only and does not materially change the previous filing made on November 3, 2023.

This filing, being made on at least 16 days’ notice as required by Section 61.56 (2) (ii) of the Code of Federal Regulations Part 47, and scheduled to become effective on April 1, 2024, consists of tariff pages as indicated on the following check sheets:
