On March 18, 2024, John Staurulakis, Inc. (JSI) filed Transmittal No. 256 in which it proposed revisions on behalf of JSI carriers who are not members of the National Exchange Carrier Association Common Line Pool and therefore bill common line charges and related Federal Universal Service Charge ("FUSC") charges pursuant to JSI Tariff FCC No. 1. The proposed revisions reflected a decrease of the Universal Service Contribution Factor for the second quarter of 2024 from the currently effective 34.6% to 32.8%. Transmittal No. 256 also introduced speed tiers for certain services on behalf of Horry Telephone Cooperative, Inc. Transmittal No. 256 was filed on 15 days notice with an effective date of April 2, 2024.

Application is hereby made by JSI for Special Permission for a waiver of the requirements of Section 61.58 of the Commission's Rules in order to file revisions to the John Staurulakis, Inc. (JSI) Tariff F.C.C. No. 1 on not less than one (1) days notice in order to advance the effective date of the revisions to April, 1, 2024. Specifically, JSI seeks to advance the effective date for only the proposed revisions concerning the reduction of the Universal Service Contribution Factor for the second quarter of 2024.

Additionally, JSI seeks a waiver of Section 61.59 of the Commission's Rules to revise tariff pages that have not been in effect for at least thirty (30) days.

Grant of the requested waivers will permit JSI to file tariff revisions to meet the required effective date of April 1, 2024 and will be in the best interest of the carriers' customers as they will benefit from the reduced contribution factor. The proposed revisions are provided in the accompanying illustrative tariff pages.
