This filing proposes tariff revisions to reflect the change in the Federal Universal Service Fund Contribution Factor for the 2nd Quarter of 2024, pursuant to the Commission's Public Notice, "Proposed Second Quarter 2024 Universal Service Contribution Factor, CC Docket No. 96-45," DA 24-257 (rel. Mar. 14, 2024).¹ Specifically, ACS proposes to decrease its charge to recover its
