Nevada Bell Telephone Company is changing its legal name to Nevada Bell Telephone Company, LLC, effective May 1, 2024, and pursuant to Section 61.171 of the Commission's Rules, NBTC is cancelling its current tariff and reissuing a tariff under the new name.

With this filing, NBTC is cancelling, in its entirety, current Nevada Bell Telephone Company Tariff F.C.C. No. 1. Simultaneous to this cancellation, Nevada Bell Telephone Company, LLC is issuing its Tariff F.C.C. No. 1-Access Services, with no changes to regulations or rates.


