Southwestern Bell Telephone Company is changing its legal name to Southwestern Bell Telephone Company, LLC, effective May 1, 2024, and pursuant to Section 61.171 of the Commission's Rules, Southwestern Bell Telephone Company is cancelling its current tariffs and reissuing tariffs under the new name.

With this filing, SWBT LLC is issuing its Tariff F.C.C. No. 3-Radiotelephone Message Telecommunications Service, with no changes in regulations or rates.
