In this filing, Nevada Bell Telephone Company, LLC (NBTC) proposes to allow customers to create new Shared Use arrangements, and moves, adds, and changes may be made to new and existing arrangements effective August 1, 2024. As of that date, all Shared Use arrangements will be rated as Special Access Service, regardless of whether the individual channels are Special Access, Switched Access, or any other type of Service. NBTC will no longer apply rate adjustments for Shared Use arrangements.


