This filing is being made by U S WEST Communications in its Tariff F.C.C. No. 5, Access Service, Sections 2, 5, and 6, to introduce Switched Access rate elements for Synchronous Service Transport (SST) comparable to the SST rate elements offered in Section 7, Private Line Transport Service. These rate elements will only apply on a shared use basis with SST ordered out of Section 7.
