4.1.6.2 Federal Universal Service Fund (FUSF) Surcharge  
(Cont'd)

(A) Application of FUSF Surcharge to Local Exchange Services

The basic FUSF Surcharge (Section 4.1.7 following) applies to all local exchange lines or trunks provided by the Telephone Company to which the End User Common Line charge applies, with the following exceptions:

- The per-line FUSF Surcharge for Centrex lines will be based on Centrex size, as set forth in Section 4.1.7 following; and
- The FUSF Surcharge for ISDN PRI services is equal to five (5) times the basic FUSF Surcharge.

(B) Application of FUSF Surcharge to Special Access Services

An FUSF surcharge will also be assessed to end user customers who order Special Access services from this tariff. The FUSF Surcharge will be determined by multiplying an FUSF Surcharge factor of .068823 by the end user customer's monthly, billing account level, interstate Special Access service charges. (C)
