19. Promotional Offerings19.1 General

(A) Digital Subscriber Line Technology

The Digital Subscriber Line Technology promotion waives the nonrecurring charges, as set forth in 8.5.3 preceding, when a customer installs a new DSL under a term discount plan. This promotion is not available to customers ordering DSL service under the volume pricing rates set forth in 8.5.4 preceding.

In the event the customer terminates its DSL TDP prior to the expiration date of the plan, any nonrecurring charges waived under this promotion will be included in the calculation of the customer's termination liability charges as set forth in 8.5.2(B)(6) preceding.
