The accompanying Tariff Review Plan and associated supporting documentation is sent to you for filing in compliance with the Communications Act of 1934, as amended. This filing is being made on by Citizens Telecommunications Companies ("Citizens").

In accordance with the Commission's requirements as specified in the Commission's *Order*, July 2, 2002 Annual Access Charge Tariff Filings, DA 02-970, April 26, 2002, ("*2002 TRP Order*") and *Order*, 2002 Annual Tariff Filings, DA 02-990, April 29, 2002 ("*May 1 TRP Order*"), Citizens is submitting revisions to its Price Cap Indices to be effective July 2, 2002. The PCI revisions are as complete and accurate as possible for this early filing date. Subsequent Commission action (e.g., adoption of a final TRS Contribution Factor) may result in revisions for the June 17, 2001 Annual Tariff Filings that are not quantifiable at this time. In keeping with the requirements of the *May 1 TRP Order*, paper copies of this Transmittal Letter and CD-ROMs containing TRP source files identical to those being filed electronically are being provided as Public Reference Copy, to the Pricing Policy Division, and to the Commission's duplicating contractor.
