10.1.9 Promotional Offerings

- (A) ADSL 60 Day Free Trial and 18-Month Term Discount Line Charge Rates for service ordered between June 16, 2002, and July 19, 2002.

During the period of June 16, 2002 through July 19, 2002, residential customers may order ADSL Option 1 and upon signing an 18-month agreement, pay nothing for 60 days during the free trial period. If the customer decides to continue past the trial period and enter the 18-month agreement period, they would pay the reduced monthly ADSL Line Charge rates listed below versus those listed in Section 10.1.8 of the tariff. Customers will be guaranteed the 18-Month Term Discount rates as identified below for a period not to exceed 18-months from the date of the end of the trial period (60 days after installation). To receive this promotional offer, a customer must place a completed order for ADSL under this promotional offer within the time period specified. This offering is not available with any other promotions.

Under the Term Discount Plan, if a customer chooses to disconnect all or a portion of the service prior to the expiration of the Term Discount period, discontinuance charges will apply to the portion of the service being discontinued. Discontinuance charges equal to one hundred percent of the total undiscounted monthly rates and installation charges identified in Section 10.1.8, less any amounts previously paid, will apply for the minimum service period. The minimum service period will be 18 months. At the end of the Term Discount period, the customer will revert back to monthly rates offered under Section 10.1.8 or may subscribe to any new Promotional Offering (if one is currently available through this tariff).
