The accompanying tariff material, submitted by ACS of Anchorage, Inc. ("ACS-ANC"), bearing Tariff F.C.C. No. 1, Access Service, is sent for filing in compliance with the Communications Act of 1934, as amended.

Transmittal No. 15, issued July 30, 2002, with an effective date of August 6, 2002, contained the incorrect revision of Tariff Sheet 16-6. ACS-ANC inadvertently filed the 5<sup>th</sup> Revised Sheet 16-6 instead of the 6<sup>th</sup> Revised Sheet 16-6. ACS-ANC requested, and was granted special permission to withdraw this tariff page prior to it becoming effective.

The first part of this filing, to become effective July 31, 2002, is being filed on not less than one days' notice under authority of Special Permission No. 02-107. This filing withdraws the 5<sup>th</sup> Revised Sheet 16-6 filed under Transmittal No. 15 without it becoming effective. ACS-ANC inadvertently submitted the previously filed tariff sheet from Transmittal No. 14 instead of the revised sheet for Transmittal No. 15.

The second part of this filing replaces the tariff sheet filed in Transmittal No. 15 with the Seventh Revised Sheet 16-6 and contains the information that should have been filed under Transmittal No. 15.

There are no additional changes from the material filed in Transmittal No. 15. Therefore, there is no additional cost support to be filed. This portion of the filing is being filed on a streamlined basis on 7-days notice with an effective date of August 6, 2002.

FCC Tariff No. 1 tariff pages, as appropriately revised, are attached to this submittal.

The original letter of transmittal, along with F.C.C. Form 159 and the required \$655.00 filing fee, are being delivered via overnight service to the Mellon Bank in Pittsburgh, Pennsylvania. Acknowledgment and date of receipt of this filing fee by Mellon Bank are requested. A duplicate letter is provided for this purpose.
