**13.23 MANAGED LONG DISTANCE**

(N)

A. General Description

Managed Long Distance (MLD) is a call management service that provides an IC the capability to offer its end user limited access to 1+ direct dialed long distance calling. Calls are routed through the MLD platform for monitoring, timing and voice prompts and subsequently routed to the IC's tandem switch.

B. Terms and Conditions

1. The Company undertakes to provide MLD only in those end offices that are suitably equipped.
2. The Primary Interexchange Carrier and Local Interexchange Carrier (PIC/LPIC) must be the same, which means that the IC must be the interLATA as well as the intraLATA presubscribed carrier.
3. The IC's end user customers are provided a \$20.00 per month spending limit from the 1st through the last day of each month.
4. At the beginning of each 1+ call, the end user is provided with number of minutes remaining in their monthly spending limit. To provide the status of the spending limit, and to enforce the spending limit, the IC must provide the Company with the rates that the IC is billing the end user.
5. MLD only applies for calls within the continental United States, Hawaii, Canada and Mexico. Calls to other locations are blocked by the Company.
6. The IC may charge different rates for calls to the United States, Canada, and Mexico. Individual states and provinces within the countries will all be charged the same rate as the IC specifies for the country.
7. MLD rates are applied on a per minute of use basis. Fractional minutes of use for each call will be rounded up to the next full minute.
