Under authority of Special Permission No. 02-131 of the Federal Communications Commission, the Verizon Telephone Companies (Verizon) hereby defer the effective date of revisions filed under Transmittal No. 250 from October 26, 2002 to November 9, 2002. Transmittal No. 250 was originally filed on October 11, 2002 to clarify the requirements and regulations pertaining to the jurisdictional determination of switched access traffic, a customer's reporting of percentage of interstate usage (PIU) factors, and Verizon's ability to obtain data from the customer to verify and/or revise its reported PIU factors.
