Dear Secretary:

Citizens Telecommunications Companies ("Citizens") submits this application for special permission to request waiver of the requirements of Sections 61.58 and 61.131 through 61.136 of the Federal Communications Commission's rules in order to file tariff revisions on same days' notice reflecting a concurrence effective November 1, 2002.

On November 1, 2002, Citizens is closing the sale of its Lisbon, ND and Gwinner, ND exchanges to Dickey Rural Access, Inc. ("Dickey"). Dickey has indicated its intention to participate in the National Exchange Carrier Association Tariff F.C.C. No. 5. The multiline business end user common line rates applicable to Dickey under that tariff would be \$9.20, as opposed the rate of \$6.00 that is applicable under Citizens Tariff F.C.C. No. 1. Dickey has indicated that it has not done the required customer notification for this rate increase, and needs to concur in Citizens Tariff F.C.C. No. 1 for a period of time sufficient to accomplish that notification. Citizens seeks the current waiver to file tariff changes implementing this concurrence effective November 1, 2002, without a formal concurrence letter. Citizens will file the formal concurrence letter when it is received.

In accordance with the Commission's fee filing requirements, the original of this Application No. 49, (without revised tariff material), together with a completed FCC Form 159 and a check payable to the Federal Communications Commission in the amount of six hundred thirty dollars (\$655.00), has been forwarded to the designated office of the Mellon Bank in Pittsburgh, Pennsylvania. Please acknowledge receipt of this filing by affixing an appropriate notation on the duplicate of this Transmittal furnished herewith for that purpose and return the same in the enclosed self-addressed envelope.
