Citizens Telecommunications Companies ("Citizens") submits this application for special permission to request waiver of the requirements of Sections 61.59 of the Federal Communications Commission's rules in order to file tariff revisions on 15 days' notice changing material that has not been in effect for 30 days.

On November 1, 2002, Citizens closed the sale of its Lisbon, ND and Gwinner, ND exchanges to Dickey Rural Access, Inc. ("Dickey") On November 1, 2002, Citizens' Transmittal No. 130 became effective, implementing Dickey's concurrence in Citizens Tariff F.C.C. No. 1. Dickey has now indicated an intent to participate in the National Exchange Carrier Association (NECA) Tariff F.C.C. No. 5 effective November 20, 2002. Citizens seeks the current waiver to remove Dickey's concurrence effective the same date Dickey becomes a participant in the NECA tariff.
