This filing is being made on 15 days' notice under the Federal Communications Commission's streamlined filing procedure, and adds rates and regulations implementing zone density pricing for switched transport and special access services provided in the state of Ohio, and adds special construction charges for the installation of fiber optic facilities designed to meet the specific requirements of Qwest Communications in the state of Florida. In addition, this filing includes minor tariff language changes designed to clarify the provision of interstate access services.
