Note 2: This Basic Rate ISDN FUS charge also applies to Basic Rate ISDN lines that are provided as part of a Centrex system, in lieu of the Centrex Station Line rate.

Note 3: For Primary Rate ISDN local exchange service, the FUS charge will be assessed at five times the Multiline Business Subscriber FUS charge per Primary Rate ISDN Interface.
