The accompanying tariff material, issued on behalf of Qwest Corporation (Qwest) FRN 0003-7467-57 (Concurring Carriers, The Malheur Home Telephone Company FRN 0003-7467-65 and El Paso County Telephone Company FRN 0004-3212-46), and bearing Tariff F.C.C. No. 1, effective as reflected on the attached tariff pages, is sent to you in compliance with the requirements of the Communications Act of 1934, as amended.

The first part of this filing is being made by Qwest in its Tariff F.C.C. No. 1, Section 8, Advanced Communications Networks, to extend its promotion to waive the Nonrecurring Charge associated with changing the Internet Service Provider (ISP) for Qwest DSL Service. This promotion was originally scheduled to end December 31, 2002 but will be extended to September 30, 2003.

Qwest is offering this promotion in an effort to retain customers. During this promotion, customers will be able to change their ISP without charge. As a result of this promotion Qwest estimates that it will be able to keep 25% of the remaining customers likely to leave and save approximately \$625,000 in revenue.

In the second part of the filing, Qwest plans to offer a DSL Service promotion. Under the terms of this promotion, customers who subscribe to DMT *QWEST DSL 256* and DMT *QWEST DSL DELUXE* will only pay a \$50 Nonrecurring Charge and \$5 for the first month of service. Customers who subscribe to DMT *QWEST DSL PRO DELUXE*, DMT *QWEST DSL PRO 640 KBPS*, DMT *QWEST DSL PRO 1 MBPS*, DMT *QWEST DSL PRO 4 MBPS* and DMT *QWEST DSL PRO 7 MBPS* will only pay a \$5 Nonrecurring Charge and \$5 for the first month of service. This promotion will run from January 4, 2003 through March 28, 2003.

Qwest is offering this promotion to stimulate demand for its DSL Products. As a result of this promotion Qwest estimates that demand for DSL Services will increase as follows: 1,884 DMT *QWEST DSL 256*, 1,173 DMT *QWEST DSL DELUXE*, 249 DMT *QWEST DSL PRO DELUXE*, 142 DMT *QWEST DSL PRO 640 KBPS*, 36 DMT *QWEST DSL PRO 1 MBPS*, 36 DMT *QWEST DSL PRO 4 MBPS* and 36 DMT *QWEST DSL PRO 7 MBPS*. Qwest expects a total increase in revenue of approximately \$1,149,199 for the promotion period.
