With respect to Coastal Utilities, Inc. (Coastal) this filing introduces, effective February 1, 2003, permanent conditions under which the nonrecurring charges for Symmetrical Digital Subscriber Line (SDSL) Service and Asymmetrical Digital Subscriber Line (ADSL) Service will be waived. The ADSL +Service nonrecurring charge waiver based on a promotional offering previously filed by Coastal expired on December 31, 2002.

With respect to Guadalupe Valley Telephone Cooperative, Inc. (Guadalupe) this filing introduces, effective February 1, 2003, permanent conditions under which the nonrecurring charge for ADSL Service will be waived. An ADSL Service nonrecurring charge waiver based on promotional offerings previously filed by Guadalupe expired on December 31, 2002.

With respect to Hargray Telephone Company, Inc. (Hargray) the filing revises rates for High Speed Internet (HSI) Access Service and introduces, effective February 1, 2003, permanent conditions under which the nonrecurring charge for HSI Access Service will be waived.

With respect to Mt. Horeb Telephone Company (Mt. Horeb) this filing also introduces, effective February 1, 2003, permanent conditions under which the nonrecurring charge for HSI Access Service will be waived. An HSI Access Service nonrecurring charge waiver based on a promotional offering previously filed by Mt. Horeb expired August 31, 2002.

Finally, with respect to Millington Telephone Company, Inc. (Millington) this filing introduces, effective February 1, 2003, permanent conditions under which the nonrecurring charge for ADSL Service will be waived.

For all of the carriers mentioned above, the conditions under which nonrecurring charge waivers will be granted are included in the respective carrier's JSI Tariff F.C.C. No. 1 Section 17 rate section.

Pursuant to Section 61.38 of the Commission's Rules, JSI is providing an individual Description and Justification for both Coastal and Hargray. Pursuant to Section 61.39 of the Commission's Rules, supporting information for Guadalupe Valley, Millington and Mt. Horeb will be furnished to interested parties upon reasonable request.
