With this filing Ameritech proposes to add Illinois to the Ameritech Saver Plus plan in the Ameritech Tariff FCC No. 4 Interstate IntraLATA Message Telecommunications Services. Ameritech Saver Plus is a "win-back" plan and is currently offered in Indiana, Michigan, Ohio, and Wisconsin. The plan was originally introduced in September 2001 with transmittal No. 1277. The addition of Illinois will not change the existing plan.
