Under authority of Special Permission No. 02-149, Special Permission No. 03-001 and of the Federal Communications Commission, Verizon is introducing Local Package Basic, a new optional service plan for residence customers in New York (FCC12) and Virginia (FCC4 and FCC15) that combines local exchange services, unlimited Intrastate IntraLATA toll usage, and the choice of available Intrastate optional central office service features together with unlimited Interstate IntraLATA service.
