3.7 Optional Calling Plans

3.7.1 Local Package Basic

(A) General

Local Package Basic is an optional service plan for residence Dial Station customers in Virginia that combines local exchange services, unlimited Intrastate IntraLATA toll usage, and the choice of available Intrastate optional central office service features (a list of these services is contained in Verizon South, Inc. General Customer Services Tariff) together with unlimited Interstate IntraLATA service. The Interstate IntraLATA portion of the Local Package Basic plan is in lieu of the regular residence Schedule I Interstate IntraLATA rate schedule provided in this tariff.

(B) Regulations

- (1) The regulations included in this tariff cover only the Interstate IntraLATA portion of the Local Package Basic Plan.
- (2) The Local Package Basic plan is available only to customers that have enrolled in the plan.
- (3) There are no applicable enrollment charges or charges for discontinuing the Local Package Basic plan.
- (4) Eligible Interstate IntraLATA toll calls are those which are customer-dialed and completed without the assistance of a Telephone Company operator.
- (5) Local Package Basic is not available in conjunction with any other regional optional calling plan or in conjunction with any other regulated regional package of optional services.
- (6) Local Package Basic is not available with Lifeline Service or IntelliLinQ® BRI service lines.
- (7) Local Package Basic allows the customer the ability to complete calls 24 hours a day, seven days a week, including holidays.
